Item 4. Personnel Movements

At the meeting of the Board of Directors (the "Board") of Nickel Asia Corporation (the "Company") held on August 3, 2023, the Board approved the following organizational changes:

- a. The Appointment of Mr. Reynaldo M. Dela Rosa as the Assistant Vice President - Community Relations

Mr. Dela Rosa has been involved in External Affairs, Community Development and Public Relations work, Information & Education campaign and implementation of Corporate Social Responsibility (CSR) projects for almost 27 years. Prior to his appointment, Mr. Dela Rosa was the Community Relations Manager and External Admin of the Company's subsidiary, Rio Tuba Nickel Mining Corporation (RTNMC) and Officer-in-Charge of the Company's Community Relations Group. He was also the External Affairs and Community Relations Manager of RTNMC

for 10 years implementing RTNMC's Community Relations and Assistance Program and Corporate Social Responsibility (CSR) programs, projects and activities; and Social Development and Management Program (SDMP). He also served as Sr. Development Communication Specialist/Information, Education & Communication Officer for Taganito Mining Corporation, a subsidiary of the Company, for 2 years.

Mr. Dela Rosa obtained his Bachelor of Arts Major in Philosophy Minor in Social Science from Saint Vincent Ferrer Seminary. He also earned MA in Public Administration, specializing in Regional and Local Government Administration from Palawan State University.

b. The appointment of Mr. Jeffrey B. Escoto as Head of NAC DPP Plant Operations

Mr. Escoto is the from Vice President - Supply Chain Management and Technical Services since March 14, 2023 and the Chief Operating Officer of the Company's subsidiary, CDTN Services Company Inc. since January 1, 2023. He will serve as Head of DPP operations concurrent with his other functions.

c. Mandatory Retirement of Mr. Gerardo Ignacio B. Ongkingco, Vice President-NAC Development Sector

Mr. Gerardo B. Ongkingco was with the Company for eight years, from February 2015 until his mandatory retirement on July 31, 2023. He served as Vice President - Human Resources from February 2015 until March 9, 2022. He was also the Data Protection Officer of the Company and its mining subsidiaries from 2017 until March 9, 2022. On March 10, 2022 he took on a new role as Head of NAC Development Sector, the learning solutions provider of the NAC Group.


