#### Subject of the Disclosure

Lifting of temporary suspension of operations export companies (including mining and mineral processing companies) and prohibition on entry of foreign vessels of export-oriented companies in Surigao Del Norte

#### **Background/Description of the Disclosure**

On 03 April 2020, Taganito Mining Corporation (TMC), and Hinatuan Mining Corporation (HMC), subsidiaries of Nickel Asia Corporation (NAC) operating in Claver and Tagana-an, Surigao Del Norte, respectively, received a copy of Province of Surigao Del Norte Memorandum Order No. 20-124 entitled Second Supplement to Executive Order No. 20-011, s. of 2020, issued by Governor Francisco L. Matugas on the same date ("SDN M.O. 20-124"). SDN M.O. 20-124, which immediately took effect, allowed among others, (i) the continued operations of export companies (including mining companies and mineral processing plants), and (ii) the entry of foreign vessels of export-oriented companies within the Province of Surigao Del Norte. SDN M.O. 20-124 modified and amended Executive Order No. 20-011 dated 28 March 2020 which temporarily suspended the operations of mining and mineral processing plants in the Province of Surigao del Norte.

With the lifting of the suspension of mining operations in Surigao Del Norte, TMC and HMC will resume their mining operations in compliance with the health and safety precautions specified in SDN M.O. 124 and the policies adopted by the NAC Group in response to the Covid-19 pandemic.

TMC and HMC will also resume their ore shipment activities, but will require foreign vessels chartered to deliver ores to their clients to strictly observe the quarantine guidelines mandated by SDN M.O. 124 for the crew of the vessels and the stevedores loading ores onto the vessels.

NAC and its subsidiaries continue to monitor and evaluate their temporary work arrangements amid the Covid-19 pandemic to ensure continuous operations without compromising the health and safety of their employees.
