Temporary suspension of mining operations in the Province of Surigao Del Norte effective 01 April 2020

#### **Background/Description of the Disclosure**

On 30 March 2020, Taganito Mining Corporation (TMC), and Hinatuan Mining Corporation (HMC), subsidiaries of Nickel Asia Corporation (NAC) operating in Claver and Tagana-an, Surigao Del Norte, respectively, received a copy of Executive Order No. 20-011 entitled "An Order Strengthening Provincial Preparedness and Response to Prevent and Control Entry and Spread of Covid-19 in the Province of Surigao Del Norte" issued by Governor Francisco L. Matugas on 28 March 2020 ("Surigao Del Norte E.O."). The Surigao Del Norte E. O., which takes effect on 01 April 2020 has mandated, among others, the suspension of operations by mining and mineral processing plants (Section 11 (c) ) and the entry of foreign vessels (except those carrying basic goods and necessities) within the Province ( Section 2.2).

NAC foresees that the suspension of mining operations may adversely affect the schedule ore shipments of TMC and HMC and their revenues for the second quarter of 2020. The impact of the temporary suspension of the operations of TMC and HMC to NAC's overall business will depend on the duration of the temporary suspension. In 2019, TMC and HMC accounted for 59% of NAC's total nickel ore shipments.

At present, TMC and HMC are prioritizing the health and safety of their employees, and are implementing all the necessary measures therefor for the duration of the State of Public Health Emergency, in compliance with the government's mandate and the policies adopted by the NAC Group in response to the Covid-19 pandemic.

NAC wishes to assure the investing public that TMC and HMC are evaluating the adjustments that need to be made regarding their operations during and after the lifting of the province-wide suspension of mining operations in Surigao Del Norte to mitigate the effects of the said suspension on their operations and financial performance.
